NOTICE

Attention: All Producers of Plastic Materials, Plastic Waste Generators, Local Bodies & Gram Panchayats

This is brought to the notice of all concerned that Ministry of Environment, Forest & Climate Change, Govt. of India has notified the Plastic Waste Management Rules, 2016 under Environmental (Protection) Act, 1986 on dtd.18th March, 2016 in supersession of the Plastic Waste (Management & Handling) Rules, 2011. The Rules shall be applied to every plastic waste generator, local bodies, gram panchayats, manufacturers, importers & producers.

The copy of the Plastic Waste Management Rules, 2016 is available in Boards' Website: www.ospcbboard.org and website of MoEF&CC: www.envfor.nic.in. As per the provisions of the Rules, the plastic carry bags or sheets with thickness more than 50 microns shall be manufactured and used. The producers and brand owners shall be responsible for plastic waste collection based on Extended Producer Responsibility (EPR). Urban Local Bodies and Gram Panchayats have the responsibility to ensure segregation, collection, storage, transportation, processing and disposal of plastic wastes. They shall ensure that open burning of plastic wastes does not take place. The local bodies are to frame Bye-Laws incorporating the provisions of the Rules. All plastic waste generators including the organisers of event in open place are required to segregate the plastic waste and pay user fees specified in the Bye-Law of the Local Bodies. The manufacturer of plastic materials are required to obtain registration from the State Pollution Control Board, Odisha. The vendors dealing with plastic carry bags shall be registered with concerned local bodies and pay registration fees as prescribed in the Bye-Law.

Let us work together to combat plastic waste menace.
